FONASBA Launches Maritime Education Course Database

Following its recent Lima Declaration commitment to support and encourage education and training in the ship agency and ship broking sectors, FONASBA has now launched the first comprehensive, searchable database of educational courses and programmes available from its member associations.

FONASBA's members span the entire globe and the range of courses provided is similarly extensive. Ranging from the Institute of Chartered Shipbrokers' Professional Qualifying Examination to a one day course on port agency, and offered in a variety of languages, the scope of courses offered is extensive, comprehensive and applicable to everyone from new entrants to senior executives. Until now, however, there has been no central access point through which prospective students can get a snapshot of all the courses currently available. The introduction of this unique FONASBA resource now enables students to search for courses by subject, delivery language and method. The results can be further refined by course length and qualification level. An option to view all the courses unfiltered is also available to ensure nothing is overlooked.

Each entry provides a short introduction to the course as well as a link to the relevant section of the association's website where more detailed information is available. Contact details are also provided.

Welcoming the launch of the database, FONASBA President Marygrace Collins said "It gives me great satisfaction to see this project completed, as FONASBA continues to provide the global shipping community with additional educational resources". Education Vice President Capt, Jakov Karmelic added "This is the initial step in implementing our Lima Declaration aim of giving an insight to the educational programmes offered by our members.
