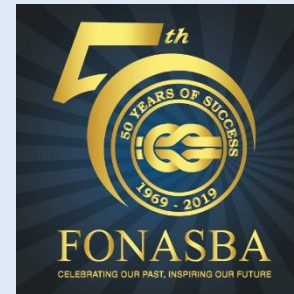
Initially, the EXECOM have thankfully confirmed the membership request of the following 3 companies in Egypt and they are now associate members at FONASBA:
