By popular demand, FONASBA has once again joined with ACB, the Barcelona Shipping Agents' Association (a member of ASECOB, the Spanish national agents' federation), to offer an online modular course for agents in liner shipping. It is open to employees of company members of any of its Full Member associations and of Associate Member companies. Your employees are therefore eligible to apply to take this course.

Unlike other FONASBA-supported courses, it has a set structure, comprising ten modules built around a series of video lectures provided by senior members of the Spanish liner shipping sector. Students also have access to a comprehensive set of supporting resources, including the opportunity to exchange comments and questions with the lecturers in a series of tutorials. To date nearly 700 students in Spain and more than 70 from FONASBA have successfully completed the course. **In view of the delivery method, this course has fixed start and finish dates, as shown above.** The course is administered by ACB and full details of how to register your employees, the fees payable and other information are provided in the attached course booklet. The main points are summarised overleaf.

Adequately and appropriately trained liner agency staff are vital for supporting your principals. FONASBA therefore recommends this course to your company and its employees.

The closing date for this course is Friday 24th March. The next course will not be held until September so you are recommended to register your students as soon as possible.

Course Commitment:

It is anticipated that the course will take approximately 60 hours to complete all ten modules.

Course Fees:

The cost of the course, including all course materials and the module assessment fees is €650.00, plus VAT if applicable. Payment must be made by bank transfer (credit card payments are not possible) and details will be provided on registration. Entry to the course will only be provided once payment is received.

Student Registration:

It is not possible for students based in Spain to register for this course via FONASBA. Students in Spain should register directly with ACB.
