# **European Shipping Summit 2023**

ECASBA has been a member of the Steering Group of the biennial European shipping event, now the **European Shipping Summit**, since its inception in 2015.

The event returned on 19<sup>th</sup> and 20<sup>th</sup> September in its new for-

mat and was held at the **Museum of Fine Arts** in central Brussels. ECASBA has again developed the agendum in partnership with the European associations representing shipowners, (ECSA), cruise lines (CLIA), maritime pilots (EMPA), tug owners (ETA), dredger operators (EUDA), ferry operators (INTERFERRY), container lines (WSC) and the European Transport Workers Federation (ETF). **The event was also supported by the European Commission**.

Spread over two days, the Summit comprised individual sessions on Tuesday 19th hosted by Steering Group members and

based around three broad themes: **Environment, Industry and People**. ECASBA has hosted a session with the World Shipping Council under the People theme, entitled "Dangerous Trade: joining forces against drug trafficking" at 1.00 pm that day. It was focused on the increasing volume of drugs being smuggled into European ports, and its impact on the ship's crews, shore-based staff and law enforcement agencies involved. ECASBA Chair Marco Tak joined representatives of

the carriers, ports and customs and border protection to discuss the topic with ESS delegates.

The main conference took place on Wednesday 20<sup>th</sup> September and featured high-level panels on subjects such as the role of shipping in securing Europe's security, maintaining the EU's competitive edge, and delivering transition both in energy and for the people involved in the shipping industry. Senior industry figures and political leaders from the European Commission were present.

The Steering Group are very pleased that this first European Shipping Summit was significantly oversubscribed, and we look forward to an informative and engaging event: https://europeanshippingsummit.eu

## **FONASBA docks in Asia**

During their recent visit to Asia the president, Javier Dulce and the President Designate, Ful-

vio Carlini visited 4 countries accompanied by the VP Asia, Takazo ligaki: Malaysia, Vietnam, Thailand and Singapore. Good meetings were held with the associations of Vietnam and Thailand. These associations were not ready to join yet, however by maintaining a close relationship with them the hope is that these may consider applying in the near future. The Singapore Shipping Association is currently unable to

join due to some internal governance bearings. However, the representatives were keen to establish alternative forms of cooperations with FONASBA, i.e. joint events and various initiatives. One very positive outcome had already been



achieved: following the visit the application from Malaysia that was unanimously approved during the Executive Committee in June 2023. So the plan going forward is that of **continuing these type** of field visits with the aim of expanding

the membership where possible. Mr. ligaki during the last Execu-Committee tive in Antwerp acknowledged the support received from the local Ben Line offices, and he stressed how he was confident that with continued and regular contact FONASBA would in due course expand its membership in Asia. All associations

visited during the mission have been invited to attend the AGM in Amman to try and consolidate the relationships.

### Visit to Brussels, June 2023



ECASBA (FONASBA's European committee), held its 2023 European seminar in Brussels on 20th June. Delegates from Belgium, Bulgaria, Cyprus, Denmark, Finland, France, Germany, Greece, the Netherlands, Portugal Spain and Sweden participated in the

event, where they were joined by FONASBA President Javier Dulce and representatives of the European Commission, Danish Shipping, the European Community Shipowners Association, the International Port Community Systems Association, and the World Shipping Council. ECASBA's Brussels representative, Frank Janssens was also present. During a full day of presentations and panel discussions, the seminar covered European

maritime policy issues such as customs policy, the European Maritime Single Window environment, and the rising tide of drug smuggling through northern European ports. On this latter subject the meeting discussed the impact on both the transport chain and, equally importantly, employees of ship agency companies. As is now traditional, the seminar closed with dinner, allowing the discussions of the day to continue in an informal social setting. Information on the location and date for 2024 seminar will follow in the new year.

# Navigation Center of Argentina Celebrated its 123<sup>rd</sup> anniversary



The Navigation Center of Argentina celebrated its 123<sup>rd</sup> anniversary on June 8th at the renowned Yacht Club of Puerto Madero in Buenos Aires. Members, authorities, CIANAM members, chambers and institutions from the maritime and port sector attended the event.

During the celebration, the president of the organization, Julio Delfino, delivered a speech and emphasized that, in a complex context,

"Today, Argentina more than ever needs consensus and teamwork to pursue objectives with positive results." He also expressed gratitude for the support of all those who are part of the chamber and called for a toast to the future: "Which is always promising, especially if we work together to make it so, as it is through our collective efforts that we make the reality of foreign trade and the maritime transport industry, which accounts for over 90 percent of Argentine foreign trade, possible."

The Centro de Navegación of Argentina also **hosted the Annual Meeting of the Inter-American Chamber of National Maritime Agents Associations (CIANAM)** that took place in the city of Buenos Aires on June 7<sup>th</sup> and 8<sup>th</sup>. The opening ceremony was conducted by the president of the Centro, Julio Delfino, who welcomed the attendees. Estenio Pinzas then delivered a message as the president of CIANAM, and on behalf of local authorities, the Interventor of the General Administration of Ports, Dr. José Beni, also delivered some remarks.

One of the most important topics discussed was related to **environmental protection, such as carbon footprint and renew-**



able energies. Norma Becerra, president of ANAMAC, Javier Dulce, president of FONASBA, and Carla Monrabal, president of Puerto Dock Sud Management Consortium, presented this subject. This panel was moderated by María Laura Filippello from Euroamerica. In this regard, Filippello highlighted the importance of focusing on the future and learning from what colleagues around the world are doing – which is made possible by events of this kind – and posed a question to the panel about what is being done today and the steps each one is taking in that direction to create a better future.

To conclude the day, Marcelo Neri, president of Fenamar and Alfonso Mingo Jozami, General Manager of Centro de Navegación of Argentina, delivered presentations in which they analyzed the **revolution of ports and their legislation, envisioning the port of the future**. At the end of the presentations, farewell remarks were given by the Presidents of Centro de Navegación of Argentina, CIANAM and FONASBA.

FONASBA would like to extend its congratulations once again to Mr. Arsenio Antonio Dominguez Velasco on his **new appointment as Secretary-General of the International Maritime Organization (IMO), effective from January 1, 2024.** FONASBA is deeply committed to supporting the IMO in addressing the challenges faced by the maritime industry and stands ready to collaborate with Mr. Dominguez and the IMO Secretariat.

# World Customs Organization

As its name suggests, the World Customs Organisation is the United Nations agency for customs matters and is headquartered in Brussels. With its membership exclusively comprising



national customs authorities (and some other UN agencies) and with no formal arrangement for consultation with the private sector, in 2005 the WCO established the Private Sector Consultative Group **"for the purpose of informing and advising the WCO Secretary General, the Policy Commission and WCO Members on Customs and international trade matters from the perspective of the private sector"**.

Following the signing of a revised **MoU between the WCO and FONASBA** in May 2014, FONASBA was invited to join the PSCG in September 2016 as the only organisation representing the maritime sector. General Manager Jonathan C. Williams FICS was the first FONASBA representative, followed in June 2018 by Past President John Foord FICS. We remained a member for the maximum of two three-year terms as allowed by the PSCG rules and our term ended in June 2022, followed by a fallow year.

Contact was reinstated with the Group in early 2023 to express our interest in rejoining. This approach was welcomed by the PSCG and formal application was made in April. Our readmission to the Group was confirmed in August 2023 and we will remain members for a maximum of six years.

We are pleased that **Hilde Bruggeman**, General Manager of our Belgian member NAVES, and an expert on customs matters, **has agreed to represent FONASBA on the Group and will take up her post with immediate effect**. We are very grateful to Hilde for giving up her time to take on this role and we look forward to benefiting from her participation.
