Denmark	Danish Shipbrokers and Port Operators	The Danish Maritime Authority is responsible for carrying out Port State Controls, which would include relevant logging of waste by the ships.
Finland	Shipbrokers Finland	Ships or the waste receiver deliver the receipt to the port directly or through an agent.
France	AMCF	Port authority agents proceed to random controls, check disposal certificates, and ship equipment.
Japan	Japan Association of Foreign-Trade Ship Agencies	Ship inspections are conducted to ensure that waste oil and other discharges are prevented equipment installed or not.
Lithuania	Limarko Maritime Agency UAB	For vessels with an on-board waste treatment system installed, operated and recognised by international certificates (with documentary evidence, as well as other modern waste management systems that reduce the amount of waste, and with the reuse and sorting of waste, the sanitary due shall be reduced by 20%.
