Survey Results: Medical evacuation from ship to helicopter

As part of our ongoing efforts to ensure the safety and well-being of our seafarers, we conducted a survey regarding the procedures and policies surrounding medical evacuations from ships by helicopter. The valuable input received has helped us better understand the current landscape and advocate for necessary improvements.

YOUR COUNTRY	Regulatory Obligation: Is the provision of helicopter medical evacuation services considered a mandatory obligation by your national maritime authorities?
Algeria	No. N/a
Argentina	Within the "International Convention for the Safety of Life at Sea" (SOLAS 74), Chapter V, Rule 7, the Argentine Republic implemented the Search and Rescue Service, made up of two forces: the Navy and the Argentine Naval Prefecture (PNA). The PNA compulsorily provides the medical radio consultation service, and both institutions provide the aerial evacuation service (SAR).
Croatia	The Helicopter Emergency Medical Service in Croatia is under the jurisdiction of the Ministry of Health. Full details are available at https://www.hhms.hr/en/
Denmark	Yes, it is the Coast Guard and Air Force that provide emergency helicopter service in case of emergencies at sea. It is the law "Beredskabsloven" that governs.

	We have our Government Non-Profit Organization named the Red Shield of David (RSOD) Service.	
	This organization was established by law in 1950. The principles of its establishment were based on the various Geneva Conventions Decisions taken between the years 1864 to 1949(A year after our young state was actually established).

	The main urgent services are delivered by the RSOD-owned or hired Ambulances. In case a very urgent evacuation is required, the RSOD is hiring a Helicopter service from Privately Owned Helicopter Operators.	
	During my/our tenure of 12 years in the Chamber I/we can't remember a case where a Seafarer was evacuated by a Helicopter from a vessel	
	to a hospital.	
	FYI, the main ports in Israel are actually located very close to major hospitals. Maybe this is the reason that if there was a CREW Member's	
	urgent evacuation to a nearby hospital, it was done by an ambulance.	
	The costs of any evacuation are at the end of the day on behalf of the shipowner and/or his insurance.	
	The shipping Agent will order the service, pay for it, and ask the reimbursement for it from the Ship Owner.	
Japan	No, when requested by the vessel medical institution or the Japan Coast Guard.	
Lebanon	No, this service is not available in Lebanon.	
Malaysia	No. This provision is unclear whether the helicopter service is available. Normally, the ship proceeds to the nearest port to disembark crew by boat.	
Malta	We can disembark sick patients either by helicopter or by launch at OPL Malta.	
Malta	No. This depends on a case-by-case basis, depending on the severity of the case and if there are any life-threatening situations. Generally, in	
	the event of an emergency, either 112 is called or, in the case of vessels, via VHF Ch. 12 (Valletta Traffic Services) or via the agent directly. In	
	these cases, if the need for a med evacuation is necessary via Helicopter service, the AFM will be contacted to proceed accordingly. Otherwise,	
	a service launch or ambulance will be coordinated.

Slovenia	No. When no other options are available to evacuate an injured seaman, helicopter assistance can be requested. This service is provided by	
	the Slovenian military.	
Sweden	Yes, but I don't know the regulations behind it.

Argentina	No. Air evacuations carried out on national flag vessels are carried out free of charge, but not on foreign flag vessels.	The costs of aerial evacuations carried out on national flag vessels are covered by the SAR Authorities themselves. However, if the evacuated crew members have a Work Risk Insurance Company (ART) and the operation occurred as a result of a work accident, it is the ART that bears the costs. In the case of foreign ships, they pay for it.

Algeria	No	No
Argentina	Yes. Air-evacuation operations are very risky. They are generally carried out in the open sea, of crew members of fishing vessels in very adverse weather conditions. Since 2010, the PNA has put a physician on board the helicopter along with rescue swimmers and thus be able to provide the crew member with first aid on the ship and, based on the diagnosis, evaluate together with the captain of the ship, their extraction and referral to a medical centre. The Argentine SAR area of responsibility is very extensive, since it goes beyond the Exclusive Economic Zone (200 miles). Therefore, for reasons of availability and distribution of means, the PNA carries out aerial evacuations within the EEZ and the Navy, outside it, with ships that can transport helicopters, increasing its radius of action.	Argentina is one of the countries in America with the highest number of aerial evacuations on the high seas. However, the State's resources for these operations are limited, and it is suggested, to maximize and improve the efficiency of the services provided, to invest in the acquisition of means with greater autonomy and better technology.
